What personal data do we process?

- First and last name
- Gender
- Address
- Telephone number
- Company size and areas of interest
- Email address
- Chamber of Commerce and VAT numbers
- Identity document in connection with RDW vehicle registration, where applicable

Why does D-TEC Products B.V. process your data?

- Performing agreements, transactions and services;
- Relationship management and newsletters;
- Product and service development, quotations, confirmations, inspecting new vehicles and other administrative activities;
- Informing you about changes to our services or products.

How do we obtain your information?

We obtained this contact information because we supplied a product or service, or because we received a request for information or a business card from you. We also carry out telephone acquisition. In the cases mentioned above, your data is stored in our system.

How long do we retain your data?

At least as long as is legally required and/or until you have sent us an unsubscribe email.

Disclosure to third parties

TrailerTec KFT. does not sell your data to third parties. However, D-TEC dealer and service organisations do use this data. We disclose your data to third parties only where this is necessary to properly provide our services or to comply with a statutory obligation. We conclude a data processing agreement with the companies to which we disclose your data.

Social media buttons

TrailerTec KFT. uses social media buttons on its website. For any posts we make on social media and our website that contain privacy-sensitive information about customers or employees of D-TEC, we ask for prior consent to use it (for example, when delivering trailers).

Accessing, rectifying or erasing your data

You have the right to access, rectify or erase your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data. In addition, you have the right to data portability. This means that you can submit a request to TrailerTec KFT. to have the personal data we hold about you sent to you or to an organisation of your choosing. You can send a request for access,

rectification, erasure, data portability or withdrawal of consent regarding your personal data to info@trailer-tec.hu. To be sure that the request comes from you, we ask you to enclose a copy of your proof of identity with the request. To protect your privacy, black out your passport photo, the MRZ (the strip of numbers at the bottom of your passport), your passport number and your citizen service number (BSN) in the copy. TrailerTec KFT. will respond to your request as soon as possible, and within four weeks at the latest.

You always have the right to unsubscribe from our newsletter. You can opt out using the unsubscribe button included in every mailing.

Data security

We take the protection of your personal data extremely seriously and take appropriate measures to prevent misuse, loss, unauthorised access, unwanted disclosure and unauthorised modification.
